By signing this waiver, I have been advised to obtain personal medical coverage. Furthermore, I agree to use my personal insurance as a primary medical coverage if an accident or injury occurs.

I also hereby give permission to Riverside Military Academy to use my name and photographic likeness in all forms and media for advertising, trade, and any other lawful purposes.

This Release and Waiver shall be governed and construed in accordance with the laws of the United States and with the laws of the State of Georgia applicable to contracts entered into and to be performed entirely therein without regard to any choice of law or conflicts of law provisions. The parties voluntarily submit to personal and exclusive jurisdiction in any action brought in any court, Federal or State, within the County of Hall, State of Georgia.
