



CAP Uniform Manual



CIVIL AIR PATROL UNIFORM MANUAL CAPM 39-1, 26 June 2014, is supplemented as follows:

ADDED:

- 5.1.1.3.2.1 Wear of the Georgia Wing Patch on the left sleeve is mandatory for all members of the wing on the Battle Dress Uniform (BDU).
- 5.1.1.4. Squadron logos on t-shirts are authorized but must meet the current design and heraldry standards of Civil Air Patrol and approved by the Georgia Wing Historian. Designs must be submitted for approval by the Wing Commander.
- 5.1.1.4.1. Units that currently do not meet this standard are authorized to wear their current t-shirt until they are no longer serviceable. They are not authorized to purchase additional t-shirts that do not meet this standard.
- 5.1.1.4.2. Activity t-shirts from any CAP activity are authorized for wear in uniform outside of the activity as long as they meet the color and construction requirement for the specific uniform.
- 5.2.1.4.2.1 Wear of the Georgia Wing Patch on the left sleeve is mandatory for all members of the wing on the Corporate Field Uniform.
- 6.2.5.1 Wear of the Blue Beret is authorized IAW CAPM 39-1 dated 26 June 2014. The Blue Beret will be worn only by members who have completed the National Blue Beret Encampment, and have proper documentation to support such attendance. No other wear is authorized. The Blue Beret may be worn with either the BDU or Corporate Field Uniform, but is not authorized with any combination of blue Air Force style service uniform or ABU. Wear of the Blue Beret is PROHIBITED when on a military installation within Georgia Wing.
- 6.2.9 Baseball caps are authorized for wear with the BDU or Corporate Field Uniform and will be black or navy blue with unit designation (format: GA-###) in silver or gold, or squadron patch (must meet current CAP heraldry standards and be approved by the Wing Historian). No other patches, writing, or insignias are authorized. No grade is authorized on this cap. Wear of unit baseball caps at other than squadron activities will be specified by the activity director.

- 6.2.9.1. GAWG activity directors may authorize the wear of a plain baseball cap of any color, except red with ABUs, for activity members. No other patches, writing, or insignias are authorized except for last names on the back of the cap. These caps can only be worn in uniform during the specific activity.
- 6.2.9.2. Units that currently do not meet this standard are authorized to wear their current baseball cap until they are no longer serviceable. They are not authorized to purchase additional caps that do not meet this standard.
 - 6.2.9.3. Squadron hats must all be the same color and construction.
- 8.2.4.5.1 Wear of the Georgia Wing Patch on the right sleeve is mandatory on the Flight Duty Uniform, unless the member is authorized to wear another patch in the same location. A list of approved patches can be found in CAPM 39-1. Note: Squadron and Group patches are not authorized on the Flight Duty Uniform, IAW CAPM 39-1, Paragraph 8.2.4.5.
- 8.3.4.5.1 Wear of the Georgia Wing Patch on the right sleeve is mandatory on the Corporate Flight Duty Uniform, unless the member is authorized to wear another patch in the same location. A list of approved patches can be found in CAPM 39-1. Note: Squadron and Group patches are not authorized on the Corporate Flight Duty uniform, IAW CAPM 39-1, Paragraph 8.2.4.5.
- 9.4.1 The following shoulder cords are authorized to be worn by Cadets of the Georgia Wing only on Class A or B service uniform, and only while within the geographic boundaries of the wing:
- 9.4.1.1 Orange Authorized one (1) per unit participating in the Cadet of the Quarter program.
- 9.4.1.2 Royal Blue/Gold Authorized for members of the Georgia Wing Cadet Honor Society (CHS), and only while members in good standing of the CHS. Vanguard # CAP0650H.
- 9.4.1.3 Gold/Black with Gold knot Authorized for the recipient of the Colonel Benjamin Stone Cadet of the Year Award (Phase IV). Only one cadet per year is authorized to wear the cord, upon receiving the award. The cord will be removed upon completion of the year, or when the next recipient is announced, whichever occurs first. Cord supplied by Georgia Wing.
- 9.4.1.4 Gold/Black Authorized for the recipients of the Phase I, II, and III Cadet of the Year at the Wing Level. The cord will be removed upon completion of the year, or when the next recipient announced, whichever occurs first. Cord supplied by Georgia Wing.
- 9.4.1.5 Grey Authorized for wear by recipients of any phase Cadet of the Year Award at the squadron. The cord will be removed upon completion of the year, or when the next recipient is announced, whichever occurs first. Cord is to be worn only at squadron activities. Vanguard # 3738555.
